## D. TERMS OF REPORT

#### D1 Regeneration planning

The Regeneration framework, which was approved by Council executive in February 2014, contains a commitment to develop regeneration plans in key areas of deprivation in West Lothian. In addition to this, as part of the Community Empowerment Act there is a requirement on all Community Planning Partnerships to develop plans to improve their most disadvantaged areas.

Eight regeneration areas have been identified in West Lothian, based on the data zones within the bottom 20% of the Scottish Index of Multiple Deprivation. To date, this process has commenced in five of the eight identified areas.

A report was provided to the East Livingston and East Calder Local Area Committee in September 2016 outlining the background to developing regeneration plans, including the processes, structures and timescales involved.

A new Community Regeneration Officer has been appointed in May 2017 to cover the East Livingston and East Calder ward area and will begin to implement the regeneration planning process in Craigshill. Work is already underway to gather relevant statistical information and to map local services and organisations. A launch event is planned for Tuesday 27 June within Almondbank Centre and will be attended by officers and agencies working in the area and local community representatives.

Regular updates on regeneration planning and progress towards developing and delivering a plan for Craigshill will be brought to each meeting of this Local Area Committee.

### D2 Promoting physical activity - Livingston Parkrun

A weekly Parkrun has taken place every Saturday morning in Livingston since 9 January 2016. At the 76<sup>th</sup> Livingston Parkrun on 3 June 2017, 320 people took part. There were 28 participants who were running the Livingston course for the first time and 71 participants set a new personal best time.

This local provision continues to be an excellent opportunity for Livingston residents to take part in free, structured, healthy activity.

#### D3 Village improvement

An application to the Village Improvement Fund to allow exterior renovations to be carried out at St Johns Lodge in Mid Calder is being finalised. Discussion is ongoing at this stage with the community and colleagues in Planning to ensure that any proposed works accommodate the village conservation status.

It is anticipated that the application will be presented to the next meeting of the Local Area Committee in September.

#### D4 Asset Transfer

An application to transfer a small strip of land at Camps Junction in Kirknewton is in the final stages of being processed. This is part of an overall package to deliver a high profile public arts work funded through a Public Arts Grant with related grounds work funded through the Village Improvements Fund; agreed at the February LAC.

# E. CONCLUSION

The actions, as detailed above, contribute to the East Livingston and East Calder ward and enable community planning partners to contribute to the Single Outcome Agreement at a local level.
