#### D. TERMS OF REPORT

# **Background**

The Regeneration Framework, which was approved by Council Executive in February 2014, contains a commitment to develop regeneration plans in key areas of deprivation in West Lothian. Eight regeneration areas have been identified, based on the data zones within the bottom 20% of the Scottish Index of Multiple Deprivation. One of the identified areas is Livingston Central, which covers the communities of Knightsridge, Ladywell and Dedridge.

A report was provided to the Local Area Committee in September 2016 outlining the background to developing regeneration plans, including the processes, structures, and timescales involved.

# **Regeneration Plan**

As reported to the last meeting of the Local Area Committee, following an extensive community consultation exercise involving over 200 residents, the Knightsridge Regeneration group had identified and agreed on the following three priorities:

- a) Improving access to services and amenities
- b) More community activity, play and learning opportunities
- c) The environment and community safety

Since the last Local Area Committee there has continued to be progress around these priorities in terms of developing actions. Further research work is being undertaken by the Community Regeneration Officer including a survey of services active in the area which will establish the reach various services active across West Lothian have in the area (i.e. the number of residents they are working with and the type/extent of this work), as well as identifying the gaps in services which partnership working or volunteering based projects could help address.

The regeneration group last met in May and since then there has been the creation of the community council, the Gala Day committee and changes to the Mosswood Community Centre management committee. Representation on the regeneration group from all three organisations, as well as other organisations in the community currently not on the regeneration group, such as the parents-staff association, will be actively encouraged.

The regeneration group will next meet in mid-September and will look to bring some focus to all the ongoing and future work in the area which will subsequently be fed into the regeneration plan. That draft of the plan will then be provided to the next meeting of the Local Area Committee in November.

#### The Vennie

# Summer Programme

The Vennie has delivered its annual summer programme over the seven weeks of the school holidays. This involved daytime provision on weekdays between 1-3pm in addition to the core clubs which run throughout the year in the late afternoon/ evenings. This included a number of trips to places such as the Kelpies/Helix Park, the Range adventure park in Broxburn and led cycle rides around Livingston.

#### Re-imagination Event, Edinburgh Book Festival

On 22 August, the Vennie took a group of young people and volunteers to the Edinburgh International Book Festival as part of their 'Re-imagination' event following an outreach programme earlier in the year which involved authors and Book Festival staff touring the new towns in Scotland to speak to residents about what it meant to live in a new town. This included some sessions in Livingston and Knightsridge.

A young person who attends Knightsridge Primary School and a resident who has become a qualified youth worker with the Vennie were part of the event, held in the Spiegeltent in Charlotte Square, and spoke about Livingston's past, present and future.

#### Community Litter Picks

The final of the three organised community litter picks took place on Saturday 4 August. This was hosted by the Vennie with support from the Woodland Trust. There were 60 volunteers who participated and collected 100 bags of rubbish from the area. Volunteers were thanked with hot drinks and food afterwards from the Vennie.

#### Community Family BBQ

The Vennie hosted a Community Family BBQ event on Friday 24 August with over 200 people attending. Activities included dancing, mini zoo, face paint and balloon modelling.

#### Choose Life

The Vennie Youth Club took part in the annual football tournament 'Game Changer-Choose Life' held at the Hibernian Training Centre. The event is to raise awareness of mental health and suicide among young males and sponsored by NHS Scotland. Once again the Vennie were successful in winning the 2018 Plate Final. David Bingham (ex-Livingston F.C.) guested for the Vennie. Neil Lennon addressed all participants at the tournament on the importance of taking care of your health.

#### Mosswood Community Centre

Mosswood Community Centre held their Annual General Meeting on 26 June. This led to a number of new committee members being added to the group, including changes to office-bearers.

The committee has met on two occasions subsequently with a view to looking to promote the facility and encourage wider use for the betterment of the community.

At their last meeting, they agreed to:

- Host a First Aid training course for committee members from the management committee as well as the new Gala Day committee. This will support volunteers to deliver events for the community.
- Set up a sub-group was agreed to look at re-establishing the café. In the shortterm, they will consider opening the café on Friday afternoons, but the first task of the group and other volunteers is to deep-clean and tidy the kitchen and café area.
- Approach CLD Youth Services and the Vennie to see if an October holiday club could be jointly delivered in Mosswood.

# Community Learning and Development - Youth Services (CLD - Youth Services)

CLD Youth Services and the Vennie piloted a Saturday night provision in Knightsridge which was aimed at 'older' young people (S1+). This was following a gap in provision for this age group being identified locally. Despite poor weather on some nights (it was intended for this to be outdoor using the park area) there was still a reasonable attendance of between 7-17 young people each week.

Given that this was during the summer and light nights it is felt that there would be a larger attendance in the darker nights, therefore the Vennie and CLD Youth Services intend to jointly run the project on a Saturday from 27 October to 15 December. If this is successful, then it would be hoped to continue to March.

In terms of the previous Tuesday and Friday children's clubs which ran in Mosswood, CLD Youth Services have advised the management committee that they will not be continuing the Tuesday club, which previously had a weekly average of 5.5 young people per week. However, the Friday club will continue (which had an average of nine young per week) from 14 September to 7 December. CLD Youth Services have advised the committee that if they wish the Friday club to continue beyond December they will need to fund this, which they will consider in turn.

#### Knightsridge Gala Day

Since the last report to the Local Area Committee, the Gala Day is now constituted with office-bearers in place. They are planning on having the Gala Day itself in May 2019 but are also hosting a fundraising event in Mosswood Community Centre on Sunday 16 September called 'Pimp My Ride'. They have created a Facebook page which has been actively managed.

#### **Knightsridge Community Council**

The Community Council has been meeting regularly since its recent formation, and also having fortnightly walkabouts in the community to monitor the environment and pick up any new issues.

The Community Regeneration Officer met with the community council in July to make them aware of the regeneration work to date, and encourage their active participation in the process going forward. They are very keen to do this, and are particularly interested in the action plan from the Environmental Visual Audit (EVA) as there were a number of overlapping issues. This will now mean there should be less duplication of effort to these issues.

The Community Council are also keen to see improvements to the environment outside the shops and houses at Logan Way. As this was identified as a potential

regeneration project in the EVA, the Community Council were encouraged to make contact with the council's local Housing service (given the land is on the council's Housing Revenue Account). The Housing Manager has invited community council representatives to a walkabout in the area with a view to looking at developing a project which the council's Street Environmental Improvement Projects fund could potentially contribute to.

There is an interim election for the community council that is being administered by Committee Services in the council. This is due to the high level of interest from people wishing to get involved it in order to allow more people to join. The deadline for nominations is 3 September 2018.

# **Environmental Visual Audit (EVA)**

At the last meeting of the LAC, members requested an update on progress with the respective actions in the EVA report. Updates, where possible, have been provided in Appendix A.

Some issues/ actions to highlight are as follows:

- As members will be aware the demolition of the Harvester building is well underway.
- Property Management and Development has arranged to have the elevations of this parade power-washed (full height) and for the gutters to be cleaned whilst the cherry picker is on-site. This work will be undertaken once the adjoining Harvester demolition work has concluded on-site.
- WLC has contacted the three shopkeepers (74/75, 77 & 78 Cameron Way) with a view to co-ordinating a project to replace all the shop-front signage in a consistent manners. Tenants may have access to the Shop Front Improvement Scheme part of the Village Improvements Fund to assist with costs.
- As detailed above, Housing and the community council are to look at potentially making improvements to the environment around the Logan Way shop.
- Network Rail has advised that they will be removing the debris and other flytipping from along the stretch of railway track on the south side from Sutherland Way to Moncrieff Way; and
- NETs and Land Services has made a number of improvements to the Loan Path including removing of a red grill from around a tree, cutting back on path overgrowth from Mosswood Community Centre and approaching the residents of Mosswood Cottages to address the overhead growth of bushes onto the path there. The Woodland Trust has similarly cleared back growth from the Woodland Area from the south end of the path towards Ladywell.

#### E. CONCLUSION

Knightsridge is part of the Livingston Central regeneration area for which a regeneration plan is being developed. An update on progress will be brought to the next meeting of the Local Area Committee.
