4. <u>NOTICE OF MOTION - WEST LOTHIAN COUNCIL ALLOTMENT</u> STRATEGY - SUBMITTED BY COUNCILLOR JOHNSTON

"Council notes that the current Allotment Strategy sets out the council's proposals and intention to;

Embrace community participation and act as a facilitator in the management of allotment gardens." *Allotments Strategy page 5 1.3

"by facilitating and enabling communities to actively manage and participate in allotment gardening." *Allotments Strategy page 3 Executive Summary

"These associations will independently manage their respective allotment gardens addressing all day to day issues relating to tenants' leases, rent collection, finance, maintenance and enforcement." *Allotments Strategy page 3 Executive Summary

"West Lothian Council will, in return, facilitate and support each association to ensure a high quality and accountable management service is delivered to the community of West Lothian." *Allotments Strategy page 3 Executive Summary

Council accepts that the clear intention of the Allotment Strategy is to empower formally constituted allotment associations to "independently" manage all issues relating to tenants' leases and further accepts that to deliver the aims and intentions set out above that it is essential for such associations to have the powers to do this.

Council therefore agrees that all decisions in respect of allotment plots, including decisions in respect of the keeping of poultry, animals or any livestock are best made by formally constituted allotment associations and therefore further agrees to amend the current Allotment Strategy to facilitate this position."

5. NOTICE OF MOTION - CUTS TO HEALTH AND SOCIAL CARE SERVICES - SUBMITTED BY COUNCILLOR CAMPBELL

The Council considered a motion submitted by Councillor Campbell in the following terms:-

"West Lothian Council SNP Group deplores the decision made by the Better Together Administration to remove £1.2M and 25 jobs from the Health & Social Care Services budget. Removal of this level of funding, coupled with skilled personnel will only help to create further health inequalities within our communities.

West Lothian Council accepts that these services support some of the most vulnerable and marginalised people living in our communities. To impose such savage cuts as are proposed, without holding full, transparent and detailed discussions with key stakeholders is inherently wrong and cannot be acceptable in a socially just society.

West Lothian Council resolves to instruct officers, as a matter of urgency, to prepare a report detailing the full impact of these cuts to services providing vital support for some of the most vulnerable and marginalised people living in our communities, and agrees that this report will be submitted to the next meeting of West Lothian Council."

Moved by Councillor Campbell, seconded by Councillor Calder.

Amendment

"The council is focused on delivering efficiencies whilst protecting priority services. The integration of health and care offers significant opportunities to streamline services between the currently separate agencies.

This will result in efficiency savings by:

- Redesign of patient/client care pathways removing duplication and integrating
- Processes (including information systems)
- Streamlined management, again removing duplication
- Reduced bureaucracy
- Reduced overhead, for example through more efficient use of property

We ask this council to write to the SNP Scottish Government for more funding for these services."

6. <u>NOTICE OF MOTION - JIM O'HARA - SUBMITTED BY COUNCILLOR</u> CAMPBELL

The Council considered a motion submitted by Councillor Campbell in the following terms:-

"West Lothian Council would like to commend the bravery and quick thinking of Council employee Jim O'Hara of Winchburgh. Without the actions of Jim and Paddy McCourt, lives could have been lost in the early hours of Thursday April 9th.

Jim, who was letting Paddy McCourt out at 1.30 am, saw flames, which had lept 12ft up the wall of his neighbour's house. A wheelie bin had been set on fire, the flames from this fire were perilously close to the gas mains for the whole row of homes.

Jim woke the family inside before raising the alarm with the Fire Brigade. He then led 38 of his fellow neighbours to the safety of the Community Hall whilst the Fire Brigade extinguished the flames.

West Lothian Council therefore resolves to write to Jim O'Hara commending him for his quick thinking and for his actions in opening the Community Hall and leading his neighbours to safety. Special mention should be made to Paddy McCourt, who helped to save his neighbours following what could have been a devastating fire in this small community."

7. <u>NOTICE OF MOTION - BARNETT FORMULA - SUBMITTED BY</u> COUNCILLOR MCGINTY

"West Lothian Council notes with concern the proposals made during the election campaign by the SNP and UKIP to abolish the Barnett Formula.

Council agrees that the retention of the Barnett Formula is in the best interest of Scotland's economy and the people of Scotland, agrees to oppose any proposal to abolish the Barnett Formula, and agrees to write to West Lothian MP's, MSP's and Lothian List MSP's setting out the Council's view."

Council notes that during the recent Westminster General Election the Scottish National Party strongly argued against the continuing austerity proposals from both Conservative and Labour parties and strongly argued for a substantial increase in the powers of the Scottish Parliament, the non-replacement of Trident, for investment in our NHS and public services, for investment to create new jobs and growth in our economy, for substantial increases in the minimum wage and protection for the weak and vulnerable in our society by ensuring adequate welfare benefits.

Council accepts that the people of Scotland have overwhelmingly endorsed the progressive politics advanced by the Scottish National Party, electing 2 SNP West Lothian MP's and 56 SNP MP's out of 59 at a national level and resolves to;

- Congratulate all council staff for the highly professional manner in which the election process was managed locally.
- Congratulate Martyn Day on his election as SNP MP for Linlithgow and Falkirk East with a swing from Labour of 22.7% and a majority of 12,934.
- Congratulate Hannah Bardell on her election as SNP MP for Livingston with a swing from Labour of 25.9% and a majority of 16,843.
- Congratulate all 59 of Scotland's MPs on their election.

Council further accepts that the people of Scotland have overwhelmingly endorsed the call from the Scottish National Party for the Scottish Parliament to be given all powers necessary to end the Westminster parties' austerity regime, to remove trident, to ensure we can grow our economy and create jobs, invest in our NHS and public services and protect the weak and vulnerable in our society by delivering adequate welfare benefits."

8. <u>NOTICE OF MOTION - SNP U-TURN - CORROBORATION IN</u> CRIMINAL CASES - SUBMITTED BY COUNCILLOR DODDS

"Council welcomes the announcement by Michael Matheson that the Scottish Government is finally dropping its proposed legislation to abolish the need for corroboration in criminal cases.

Council takes the view that the proposed legislation on corroboration was the latest in a long line of the SNP Government forcing through hurried and ill-considered legislation in the face of opposition from stakeholders, including experts in their fields.

Council calls on the SNP to consult widely and to listen to opinions that do not agree with their own when bringing forward revised proposals for the justice system and to extend this to all future legislation."

Moved by Councillor Dodds, seconded by Councillor Fitzpatrick.

Amendment

"West Lothian Council welcomes Justice Secretary, Michael Matheson's recent announcement to review the Scottish Government's proposed legislation to abolish corroboration in crimes such as sexual assault and rape.

Council notes that the SNP Government put forward the proposal to abolish the general requirement for corroboration for a very good reason – to see more people who commit crimes in private – crimes such as sexual assault and rape – brought to trial and, if found guilty brought to justice.

Council applauds the fact that the SNP Scottish Government's absolute dedication to protecting vulnerable people has not changed. Council notes that it is largely women and children and the frail and the vulnerable who suffer behind closed doors.

Council notes that the former justice secretary listened to the serious and genuine concerns that were being raised, which is why he asked Lord Bonomy to carry out the work that he has now completed and further notes that a range of changes have been recommended to the justice system and that the justice secretary, rightly and properly, has decided that we need to pause and consider those reforms.

Council further notes that the Labour Manifesto in 2011 said they would abolish corroboration for rape and sexual offences. Council further notes Labour went back on that commitment following their shameful Better Together alliance and that Labour are now opposing – not just their own manifesto, police and prosecutors – but are pitted against Rape Crisis Scotland, Victims Support Scotland and even charities for the elderly.

Council notes the Labour argument that when the SNP Government presses ahead with a plan, that is steamrollering and when they take the chance to listen, reflect and admit that a proposal might not have got everything right, that is described as a U turn.

Council dismisses this Labour argument and accepts that the SNP Scottish Government has done the responsible and sensible thing.

Council asserts that our justice system must provide the appropriate balance, so that the rights of suspects, victims and witnesses all get the protections they deserve. It must, as far as possible, be fair to all.

Council welcomes the recent First Minister announced funding of £20M over three years which to speed up the processing of cases through the courts, support victims and tackle the behaviour of perpetrators to stop reoffending. Council acknowledges that this funding has been widely welcomed by victims' organisations.

Council further welcomes the commitment from the SNP Scottish Government to continue to work with victims' organisations to protect victims' rights, improve access to justice and continue to tackle the scourge of sexual and private space violence in Scotland."
