## 4. <u>NOTICE OF MOTION - SNP CONDEMN SHAMEFUL TORY TAX</u> CREDIT CUTS

The Council considered a motion submitted by Councillor Johnston in the following terms:-

"West Lothian Council notes new figures showing the 'shameful' impact of Tory cuts to tax credits – with almost 350,000 children set to be worse off as a result of changes announced in George Osborne's budget.

Council notes that new figures from the Scottish Parliament Information Centre (SPICe) show that 197,200 families in Scotland with a total of 346,000 children have been hit by the changes to tax credits and that these figures come in the aftermath of an IFS report showing that the vast majority of children in poverty in the UK live in working households as the Tory government's relentless assault on the poor continues.

West Lothian Council SNP group assert that George Osborne's shameful cuts were always going to hammer those in our society who were already struggling to get by – and these figures show that it is children who are going to pay a particularly heavy price, with almost 350,000 set to lose out.

West Lothian Council SNP group further assert that the Tory UK government should be utterly ashamed that the number of children from working families living in poverty has grown under their watch for, as these cuts to tax credits show, they are intent on intensifying their punitive cuts agenda as their slavish devotion to right-wing ideology trumps any commitment to supporting those in need.

West Lothian Council SNP group further assert that working families and vulnerable people in Scotland can't afford for decisions over the economy and social security to continue to be made by the Tory Westminster Government and it is time for these powers to be transferred to Scotland – allowing us to take real action to truly tackle poverty, support working families and give our children all the support they need – rather than continuing on the UK Government's course, which will push even more children into poverty."

## 5. <u>NOTICE OF MOTION - SUPPORT FOR THE BBC - SUBMITTED BY</u> COUNCIL LEADER JOHN MCGINTY

The Council considered a motion submitted by Councillor McGinty in the following terms:-

"West Lothian Council welcomes the contribution made by the BBC to the lives of citizens across the UK and beyond since its establishment, and notes the value of having a public broadcaster run independently from Government.

Council particularly welcomes the distinctive and successful contributions made by BBC Scotland, and notes that for the first time the Scotlish Parliament will have a consultative role in the BBC charter renewal process, granted following the Smith Commission.

West Lothian Council agrees that it is vital that the BBC remains adequately and independently funded, and free from political interference, and agrees to write to the leaders of all political parties represented in the Scottish Parliament to express this view and to encourage their support for a publicly funded and politically independent BBC."

Moved by Councillor McGinty, seconded by Councillor Dodds.

#### Amendment

"West Lothian Council welcomes the involvement of all the UK Devolved administrations, in the BBC charter renewal process.

Culture ministers from the devolved nations in the UK have said broadcasting should be representative of communities, regions and nations across the UK.

In particular, equality and fairness of funding is paramount to provide opportunities for local companies and individuals, to maximise and increase commissioning of original programming showcasing our local communities and what they have to officer.

To that end West Lothian Council will write to Fiona Hyslop, Scottish Culture Minister, offering support in her involvement in the charter renewal process."
