1. <u>DECLARATIONS OF INTEREST</u>

<u>Agenda Item 6 – Paediatric Services/Paediatric Outpatient Clinic Waiting</u> <u>Times</u> – Martin Hill declared an interest due to him being a member of the Paediatric Programme Board

2. <u>MINUTE</u>

The group confirmed the Minute of its meeting held on 18 January 2017 as a correct record.

3. <u>PAEDIATRIC SERVICES/PAEDIATRIC OUTPATIENT CLINIC WAITING</u> <u>TIMES</u>

The Stakeholder Group noted the update provided by Fiona Mitchell, Director of Women's and Children's Services on the current position within paediatric services at St John's Hospital.

The group heard that as at the end of January 2017 the number of children waiting 12 weeks or more was 9.

Additionally 3 new paediatric consultants had taken up post with the remainder due to start in March 2017. There were also two consultant posts remaining unfilled but an advert for these had been placed in the appropriate journals and the closing date was Sunday 19 February 2017.

Management remained confident that there would be a good response to these adverts.

In relation to a question asked on the rota now being more stable as a result of the new consultant taking up post, Fiona responded that the rota could not be considered fully stable until all vacant posts had been filled. However the rota had remained satisfactorily covered for the whole of January, February and March. A few gaps remained in the April rota but with regular meetings taking place it was hoped that this would be an improving picture.

In relation to a further question from the group in terms of outpatients waiting times improving as a result of the new consultants coming online, Fiona responded by stating that NHS Lothian fully expected to see an a rapid improvement in waiting times as a result of further consultants coming into post.

The group thanked Fiona for the update.

4. <u>ST JOHN'S HOSPITAL QUALITY DASHBOARD</u>

The group considered a report (copies of which had been circulated) by Agnes Ritchie, Associate Nurse Director providing details of a number quality measures as at the end of January 2017.

The group were advised that the quality measures were split into three categories; these being Person Centred, Safe and Effective. The report then provided a series of charts and graphs demonstrating a range of outcomes. It was to be noted with regards to Person Centred outcome the measure on "Tell us Ten Things" was on hold for the moment due to the "getting to know you" documentation.

Agnes amplified a number of statistics in the report including advising the group that the number of falls had increased because the hospital was dealing with more frail elderly patients and that she was actively working with the Fall Co-ordinator on this. The group were also advised that St John's Hospital remained a high performer in unscheduled care.

Ms Ritchie then responded to questions from members of the group.

Diabetes in Lothian: ECED

- Previously: 3 separate Diabetes/Endo depts.
- Each unit managed by CD for acute medicine
- Oct 2010: Edinburgh Centre for Endocrinology (ECE): RIE and WGH
- Feb 2014: ECE and Diabetes (ECED). Incorporated SJH
 - Pan-Lothian scope
 - Unifying clinical protocols
 - Robust cross-cover for sub-specialty services
 - Weekly cross-city meetings by VC (RIE, WGH, SJH).
- CD D&E appointed Dec 2015. Move to OAS April 2016
- CD is also clinical lead of diabetes MCN
- Align strategic and operational priorities
- Realise our pan-Lothian ambitions



Diabetes Managed Clinical Network (MCN)

- Established 2006 as part of diabetes strategy to support joined up care between diverse professionals and patients.
- Mission statement: to promote optimum health for all people with diabetes in Lothian through the design and delivery of an integrated service
- Aims of the network
 - To minimise complications and premature death in diabetes
 - To maximise quality of life by detecting and treating the disease and its complications at an early stage
 - To provide equal access to high quality diabetes care for all
 - To ensure all people with diabetes are given the right treatment by the right person at the right time in the right place

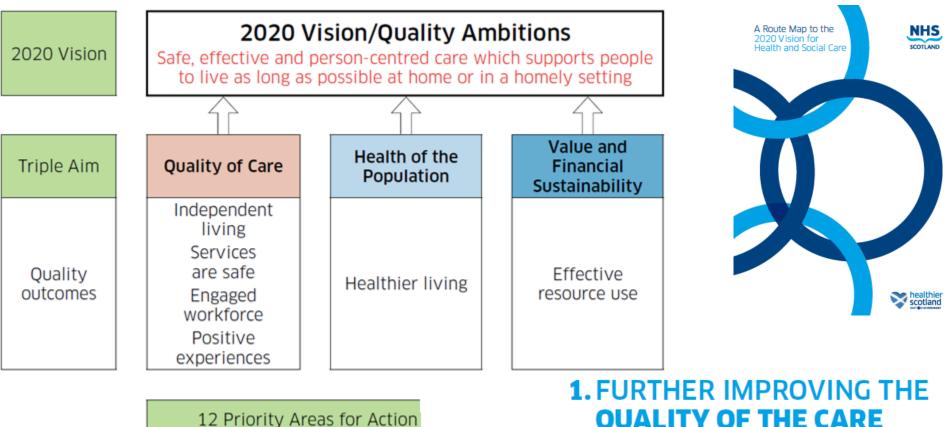

Wider context: 2020 Vision for Health and Social Care



'Our vision is that by 2020 everyone is able to live longer healthier lives at home, or in a homely setting. 1. FURTHER IMPROVING THE QUALITY OF THE CARE WE PROVIDE WITH A PARTICULAR FOCUS ON:

Increasing the role of primary care – There is now a strong consensus on the urgent need for an expanded role for primary care and general practice in particular. This is at the heart of our 2020 Vision

Challenges: technology in diabetes

- Insulin pumps:
 - 11% T1DM adults in Lothian on pumps (SNP target 20%)
 - Each pump costs ~ £2500 with annual consumable costs of ~ £3000
 - Non-recurring funding to cover growing costs of service
- Continuous Glucose Monitoring (CGM)
 - NICE guideline T1DM recommends CGM if problematic hypoglycaemia or if HbA1c persistently >75nmmol/mol despite ≥10 tests a day.

- Freestyle Libre (Flash GM)
 - £150 start up and £100 pcm
 - Not on prescribing tariff
- Sensor augmented pumps
 - CGM speaks to pump
 - Cost implications for the future









Examples of pan-Lothian working

- Pan-Lothian services
 - DAFNE
 - Insulin pumps
 - Sub-specialty clinics/MDT: thyroid eye, TYA, thyroid cancer
 - Cross-cover for consultant and DSN sick leave at SJH
- Pan-Lothian education
 - ECED meetings
 - RCPE evening meetings
- Pan-Lothian research
 - Guidepost (coaching for T2DM)
 - STEP: Scottish Type 1 Education Programme
- Pan-Lothian trainees



Examples of pan-Lothian working

- Pan-Lothian MCN
 - Previous clinical lead was Dr Karen Adamson, SJH
- Pan-Lothian directorate
 - Professional lead on each site, 3 site representation on operational group
 - Upgrading works in OPD1 SJH
- Pan-Lothian vision
 - ECED vision being updated. Aims include cross-site equity (clinical care, DCAQ)
 - Diabetes visioning day in May
- Moving forward
 - Linking in with IJBs (x4!)
 - WL Community DSN not replaced; DSNs and consultants covering the work
