7. <u>CLIMATE EMERGENCY WORKING GROUP RECOMMENDATIONS -</u> <u>REPORT BY HEAD OF PLANNING, ECONOMIC DEVELOPMENT AND</u> REGENERATION

The SNP Group, having fully participated in the Climate Emergency Working Group, are disappointed to have reached this stage without having any structure in place to drive the ambition of this Council to not only declare a Climate Emergency but to deliver the policies which will make a contribution to achieving our targets.

The proposals within this report only state "report to PDSP", with no specific PDSP, either being mentioned or having the ability to "govern" the strategy if it straddles more than one PDSP eg Procurement.

The SNP Group are dismayed at the tokenism displayed by the Labour Group at the recent Budget meeting. Having argued against setting any governance procedures as it was "too early", they then allocated a token balancing figure for one year of £802k, plucked from thin air, as a Climate Emergency Fund.

The SNP Group proposes that Council recognises the serious threat of Climate Change and that a proper governance scheme is paramount and has to be established as a priority.

Council therefore agrees to:

Call for the current review of PDSP remits as per decision of Council Executive, 20 August 2019.

(This decided how officers should proceed, one was for officers to bring forward proposals for retaining nine PDSP's by adjusting PDSP remits to include modernisation and digital transformation; revising and updating all PDSP remits to reflect the services now delivered by the Council; including rebranding the Voluntary Organisations PDSP to give recognition to its wider role in the community)

Come to P&R PDSP in April and then to Council in May and that the report looks at the option of creating a specific PDSP with the remit of Climate Action. The new PDSP membership to comprise of 2 Labour, 2 Conservative and 2 SNP members and appropriate members from our community. The Chair and Vice Chair should rotate yearly between the Conservative Group and the SNP Group and the first meeting should be held in June. There will be no responsibility allowance for the Chair."
