D. TERMS OF REPORT

Under the council's Health, Care and Support Services Procurement Procedures the Head of Social Policy is required to report bi-annually to Social Policy PDSP on the care and support contracts awarded or extended within this period and any general update on contract activity. There is also a requirement to report bi-annually on contract performance.

Contract activity

• Appendix 1 details the Social Policy contracts which have either been awarded or amended under the guidance of the Social Policy Contracts Advisory Group.

Contract performance

• Out of a total of 98 providers there were no providers who attracted a risk score of red (high), 17 providers attracted a risk score of amber (medium) and 81 providers attracting a risk score of green (low) as detailed below:

• Substance Misuse and Mental Health

There are 14 providers delivering substance misuse and mental health services in West Lothian all of these providers have been assessed as having a risk score of green (low)

• Children, Young People and Families

There are 11 providers delivering services for children, young people and their families in West Lothian all of these providers have been assessed as having a risk score of green (low)

• Care at Home

There are 15 providers delivering care at home services in West Lothian 7 of these providers have been assessed as having a risk score of green (low) and 8 have been assessed as having a risk score of amber (medium). The amber rating is associated with volume of business, contract value, vulnerability of services users

Residential Services

There are 14 providers delivering residential care in West Lothian, 12 of these providers have assessed as having a risk score of green (low) with 2 assessed as having a risk score of amber (medium). The amber rating is associated with contract value, vulnerability of services users and a reduction in Care Inspectorate Grades since the last inspection

Learning Disability, Physical Disability and Autism

There are 29 providers delivering services for people with learning disabilities, physical disabilities or autism in West Lothian, 27 of these have been assessed as having a risk score of green (low) and 2 have been assessed as having a risk score of amber (medium). The amber rating is associated with vulnerability of their clients and value of contract.

• Advice, information and Advocacy

There are 5 providers delivering advice, information and advocacy services in West Lothian all of these providers have been assessed as having a risk score of green (low).

Community Based Support for Older People

There are 10 providers delivering community based support services for older people in West Lothian, 5 of these providers have been assessed as having a risk score of green (low) and 5 have been assessed as having a risk rating of amber (medium). The amber rating is associated with vulnerability of their clients, value of contract and financial position..

E. CONCLUSION

The report provides an update for the period 1 October 2020 to 31 March 2021 on the council's contract activity for the provision of care and support services in West Lothian as required under Council Standing Orders and Procurement Procedures.
