

Cost of Living Short Life Working Group

1. Purpose of Report

The purpose of the report is to update the Community Planning Partnership (CPP) Board of the actions undertaken by the Cost of Living Short Life Working Group.

2. Recommendations

The CPP Board is asked to note the collective actions taken by the short life working group to help mitigate the impact of the cost of living crisis.

The board is also asked to note the targeted work undertaken to raise awareness of the local help and support available.

3. Discussion

In August 2022, a report was presented to the Community Planning Partnership Board highlighting the impact of the rising cost of living on poverty in West Lothian. The CPP board was asked to consider the impact of the cost of living crisis and measures which could be implemented locally to support residents most at risk of poverty and deprivation.

CPP members agreed that the cost of living crisis has impacted on many people in our communities as well as the council, community planning partners and staff, either on a personal or professional level. Partners also agreed that West Lothian is an area rich in resource with strong partnership networks and that partners play a crucial role in supporting residents facing poverty and financial crisis by identifying gaps in current service provision and developing opportunities for collaborative work. It was agreed a short life working group be convened to co-ordinate activities which would support our communities.

The short life working has met three times and has brought together Community Planning Partners, local authority and the third sector to consider practical ways in which support can be provided to households affected by the cost of living crisis. The remit for the group is attached in appendix 1.

Key actions undertaken by the short life working group include:

Cost of Living Conference

On Tuesday 4 October 2022, a Cost of Living Conference brought together partners from across West Lothian to discuss the impact the cost of living crisis is having on households and the support currently available to those households, both financial and non-financial. The conference aimed to open discussion about demand on services, map what was available locally, identify gaps and how services can work collaboratively to support West Lothian communities. There were 100 tickets booked for the conference with 82 people attending.

Feedback received from attendees was as follows:

- The conference was a good opportunity to network with people face to face after a period of remote working.
- People were very complimentary of the speakers, stating that they found them inspiring and insightful.



• Workshops were well received and people welcomed the opportunity to hear about local support available and discuss/share experiences and opportunities with colleagues from other services and organisations. Participants were keen to see a directory of support developed which listed all support organisations across West Lothian and their opening times and availability to take referrals allowing frontline staff to signpost and refer as appropriate. Organisations also signed pledge cards to take forward conversations around an affordable furniture network.

Challenge Poverty Week

Challenge Poverty Week is an initiative which helps to highlight the scale, challenge and impact poverty has on households across Scotland. At a local level, it is an opportunity for organisations and individuals to showcase what is being done to tackle poverty. This year Challenge Poverty Week took place from 3-7 October 2022.

The key messages for this year's Challenge Poverty Week included:

- As a result of the rising Cost of Living, many people in Scotland are being swept into poverty.
- There are benefits, grants and support available which may alleviate some of the pressures that families are feeling. It is more important than ever that people access the support they need to unlock poverty's grip.
- The rising cost of energy is a great concern and is set to sweep millions of people into poverty this winter. Action must be taken by all levels of government to ensure people are able to adequately and affordably heat their homes.
- To afford everyone enough to live a dignified life, the economy needs redesigned to make jobs flexible, secure and paying at least the real living wage.
- As with during the pandemic, there is no doubt that community organisations will once again be a primary port of call and frontline support to people struggling with the rising cost of living.
- Public services are crucial in helping people to participate in society and live decent lives. When services like transport, childcare and broadband are easily affordable and accessible, they can increase opportunities and help people to thrive.

During Challenge Poverty Week, partners offered a range of events from a Cost of Living Conference and community information stalls to an 'Ask the Advisor session' on the council's Facebook page and an online jobs fair. In total there were 19 activities on the 2022 Challenge Poverty Week programme. After previous years events being delivered primarily through online channels as a result of the pandemic, events this year involved a mixture of in person and online.

Welcoming Warm Spaces

The Cost of Living Short Life Working Group agreed a sub group be formed to lead on a mapping exercise identifying locations for 'Warm Welcoming Locations' across West Lothian. The aim of the sub group is to identify potential locations, map and co-ordinate activities and create a platform for organisations to assist in the provision of warm hubs and wrap information



and support around the warm hubs allowing those attending a choice of where, when and how they access any support needed.

The approach taken by the sub group to identify locations is threefold:

Council Premises: Officers identified locations where the provision of "warm spaces" can be incorporated with existing resources and promoting existing activities. This is centred around Libraries, Partnership Centres and promotion of existing activities taking place in our community centres and village halls.

Community Partners and Stakeholders: A number of community planning partners have identified locations which can be opened up as potential warm locations and be included in the mapping process whilst existing activities are taking place.

Community Education Associations and faith based organisations: Community Education Associations have shown a keen interest in being part of the warm welcome locations in addition to existing activities or assist in a promotional campaign of current activities within their facilities.

An online map has now been developed <u>www.westlothian.gov.uk/warm-welcome</u> this has been overlaid with the access to community food map and access to free sanitary products will also be added to this map. This means that all provision available is located on one map and those seeking help will be able to easily locate what is available to them in their own locality.

It is anticipated that the availability of "Warm Welcome Locations" will grow over the winter months and a commitment has been made to update the map at regular intervals. Therefore, it is clear that we need to have a flexible approach and provide a platform for any potential venue/organisations to be able to seek advice, not only from the council but their peer groups.

'Help with Costs' Publicity Campaign

On 26 October 2022, the 'Help with Costs' campaign was launched to provide local residents with cost of living advice. The campaign aims to highlight advice and information that is available on: energy, Benefits, financial support and help with school costs.

Self-help booklets have been developed and printed providing practical advice with hints and tips to help with the rising costs, booklets are available across West Lothian in libraries, schools and within voluntary organisations premises. A dedicated online information hub has been created to hold all cost of living support information within one area allowing for improved accessibility to information. <u>www.westlothian.gov.uk/costofliving</u>

Targeted Take Up campaigns

There are benefits, grants and financial support available which may alleviate some of the pressures which are being place on low income households. It is important that people access the support they need. Multi-media campaigns are being developed with partners to create targeted take up campaigns. There has been a focus on increasing the take up of Pension Credits, Adult Disability Payment and the Scottish Child Payment.



Winter Pop up Information/Advice Sessions

As a result of a request from community councils and in collaboration with community organisations work is underway to deliver winter pop up information sessions in key communities across West Lothian. These include: Dedridge, Bridgend, Fauldhouse, Blackburn, Armadale and Whitburn. The aim of the winter pop up sessions is to bring help and support into local areas which have the highest level of low income households.

It is clear that the direct and lasting impact of the rising cost of living will continue to be a concern for many households throughout 2022 and 2023. The short life working group will continue to meet and work collaboratively in delivering actions to support those affected. An action plan has been developed to track the progress of the actions and is attached at appendix 2.

However West Lothian is an area rich in resource with strong partnership networks that can be further developed and strengthened through continued co-ordination to support our communities.

The current Anti-Poverty Strategy will soon reach the end of its lifetime. A full review and refresh of the strategy will be undertaken this year and partners will have an opportunity to



contribute to consultation and discussion to shape 2023-2027 strategy. Partners are asked to continue to consider how to engage with and support people who are facing poverty and potential destitution as a result of rising costs and low income.

Cost of Living Short Life Working Group Remit

<u>Remit</u>

The remit of the Cost of Living Short Life Working Group is to consider the impact of the crisis on local people living and working in West Lothian. Partners will work collaboratively through forward planning, sharing of resources, analysing local data, looking at best practice elsewhere to develop practical actions and activities. The Short Life Working Group will put forward recommendations to the Anti-Task Task Force for inclusion in the West Lothian Anti-Poverty Strategy's annual action plan which will include lead organisation, timeline and outcome to be achieved taking into account public sector funding constraints, economic uncertainties and welfare reform agenda.

Frequency of Meetings

The Short life working group will meet four weekly to evaluate agreed actions. Ad hoc meeting may need to be convened earlier than 4 weeks if something urgent requires to be discussed.

Lead Officer

The short life working group will be chaired by the chair of the West Lothian Community Planning Partnership Board. Donald Forrest, Head of Finance and Property Services will be the lead officer.

Contact

The Anti-Poverty Manager is the main contact for any enquiries.

Reporting

The cost of living short life working group will report to the Anti-Poverty Task Force. This will include regular updates on the progress of defined actions or programmes of work that have been agreed as part of the short life working group. Reports will also be presented as required to the Anti-Poverty Task Force.

Responsibilities

- Agree collaborative actions to help mitigate the cost of living crisis locally in West Lothian
- Monitor and Evaluate agreed actions
- Provide quarterly reports to the Anti-Poverty Task Force

<u>Membership</u>

Participants are chosen to provide the relevant knowledge and expertise to fulfil the remit of the Cost of Living Short Life Working Group. Representation on the Task Force will be drawn from relevant partners in West Lothian who have a remit and interest in the Cost of Living Crisis. It will be the responsibility of each organisation to choose their representative.

This will include:

- Voluntary Sector organisations
- Organisations from West Lothian Community Planning Partnership
- Councillor Representation from the Community Planning Board
