REQUEST FOR AMENDMENT TO SCHEME FOR ESTABLISHMENT OF COMMUNITY COUNCILS IN WEST LOTHIAN - REQUEST FOR THE FORMATION OF A SEPARATE CARMONDEAN COMMUNITY COUNCIL

REPORT BY HEAD OF CORPORATE SERVICES

A. PURPOSE OF REPORT

To report to Council on the public consultation undertaken and to invite the Council to consider whether the community council boundary, for Carmondean & Deans Community Council, should be altered to allow the creation of two separate community councils for the areas of Carmondean and Deans, as requested in the petition signed by registered electors from Carmondean considered by Council Executive on 4 October 2022.

B. RECOMMENDATION

- (a) That Council noted the responses to the public consultation undertaken and considers whether to approve the alteration of the boundaries set within the Scheme for Establishment of Community Councils in West Lothian (Scheme), to allow the creation of two separate community councils for the areas of Carmondean and Deans
- (b) That if Council is minded to alter the Scheme boundaries for Carmondean and Deans, Council determines whether to adopt –
 - Option 1 – separate boundaries for Carmondean and Deans as they were prior to the introduction of the 2021 Scheme as shown in Appendix 3, or
 - Option 2 - alternative Carmondean and Deans area boundaries which were suggested in comments from a Consultation respondent as shown in Appendix 4.

D. TERMS OF REPORT

At its meeting held on 4 October 2022, the Council Executive heard that a petition had been received from registered electors in the Carmondean area, calling on the council to re-establish a separate community council for the Carmondean area. Community council boundaries are defined within the Scheme for Establishment of Community Councils in West Lothian which was last reviewed in 2020/21, and adopted on 31st August 2021. The area of Carmondean is currently represented by Carmondean & Deans Community Council. Its area boundaries are shown in Appendix 1.

Council Executive agreed to undertake full consultation with Carmondean & Deans Community Council, Ward Members, petition signatories and members of the public, prior to inviting a special meeting of West Lothian Council to consider and determine whether to alter the boundary of the current Carmondean & Deans Community Council, and establish separate community councils for the areas of Carmondean and Deans.

In terms of Section 53 of the Local Government (Scotland) Act 1973, a new community council boundary cannot be adopted until (a) elected members agree to review that element of the Scheme and (b) full consultation has taken place with the affected community council and members of the public.

Council Executive noted that given the limited nature of the requested amendment, there was no requirement to comply with the lengthy statutory timescales which would otherwise be required when adopting a comprehensive new Scheme. It agreed that three shortened stages of public consultation should take place to ensure that, if the Scheme were to be altered, any change could be implemented expeditiously.

The three stages of consultation carried out were as follows:-

- Stage 1 – Advert in the West Lothian Courier - 13th October – 2 weeks for comments – closing date 27th October 2022. 6 comments were received.
- Stage 2 – Advert in the West Lothian Courier – 10th November – 2 weeks for comments – closing date 24th November 2022. 2 comments were received.
- Stage 3 – Advert in the West Lothian Courier – 15th December – 2 weeks for comments – closing date 29th December 2022. 10 comments were received.

Appendix 2 sets out all of the comments received during each stage of consultation. The Council will take the comments into full consideration prior to determining the outcome of the petition, calling for the established of separate community council areas for Carmondean and Deans.

If 2/3rds of present, participating, Council Members agree to alter the boundaries, the existing Carmondean & Deans Community Council will automatically be dissolved. They will be asked to hold a dissolution meeting at which any funds specific to the distinct community council areas of Carmondean and Deans, will be retained and passed on to the relevant new community council once established. This shall include, for example, Covid-19 recovery projects and town centre improvement projects. All other funds held by Carmondean & Deans Community Council, such as balances accumulated through unspent annual grant funding, shall be split equally between the two community council areas.

Should Council Members agree to alter the Scheme boundaries for Carmondean and Deans, they will consider and determine whether the adopted area boundaries should be those shown in Appendix 3 (which mirror the boundaries prior to the creation of a combined Carmondean & Deans CC in the 2021 Scheme), or those shown in Appendix 4 which shows the boundaries proposed by a Consultation respondent detailed in their comments. The boundaries shown in Appendix 4 show the proposed incorporation of Beechwood Park, Elmwood Park, Harburn Avenue, Harburn Avenue West, Larbert Avenue, Lenzie Avenue and Netherwood Park into the Deans Community Council area in terms of the Consultees proposal.

Following determination of boundary areas by Council Members, arrangements will be made to issue election notices calling for nominations to both Carmondean and Deans Community Councils. A minimum of 4 valid nominations will require to be received for each area in order to set up their community councils. Contested elections will only be necessary if more than 4 nominations are received for an area. If less than 4 nominations are received, no community council will be established.

If the boundary changes are not approved by 2/3rds of the present, participating, Council Members the existing Carmondean & Deans Community Council will continue to operate until the next 4-yearly community council elections, which are due to take place in September/October 2025. Prior to those elections, a full scheme review, including boundaries, will be undertaken in accordance with normal council practice. In those circumstances, Electors from Carmondean, who signed the petition, will be advised of the Councils determination, and will be provided with advice on how they may connect with, and become more involved with, Carmondean & Deans Community Council.

E. CONCLUSION

All comments received during the three stages of public consultation, are summarised in Appendix 2. Council Members will take those comments into account in determining whether to approve the request for separation of the Carmondean and Deans Community Council, and determining the appropriate boundaries for the separated Carmondean and Deans areas, in terms of the proposed boundaries shown in Appendix 3 or 4 to this Report.

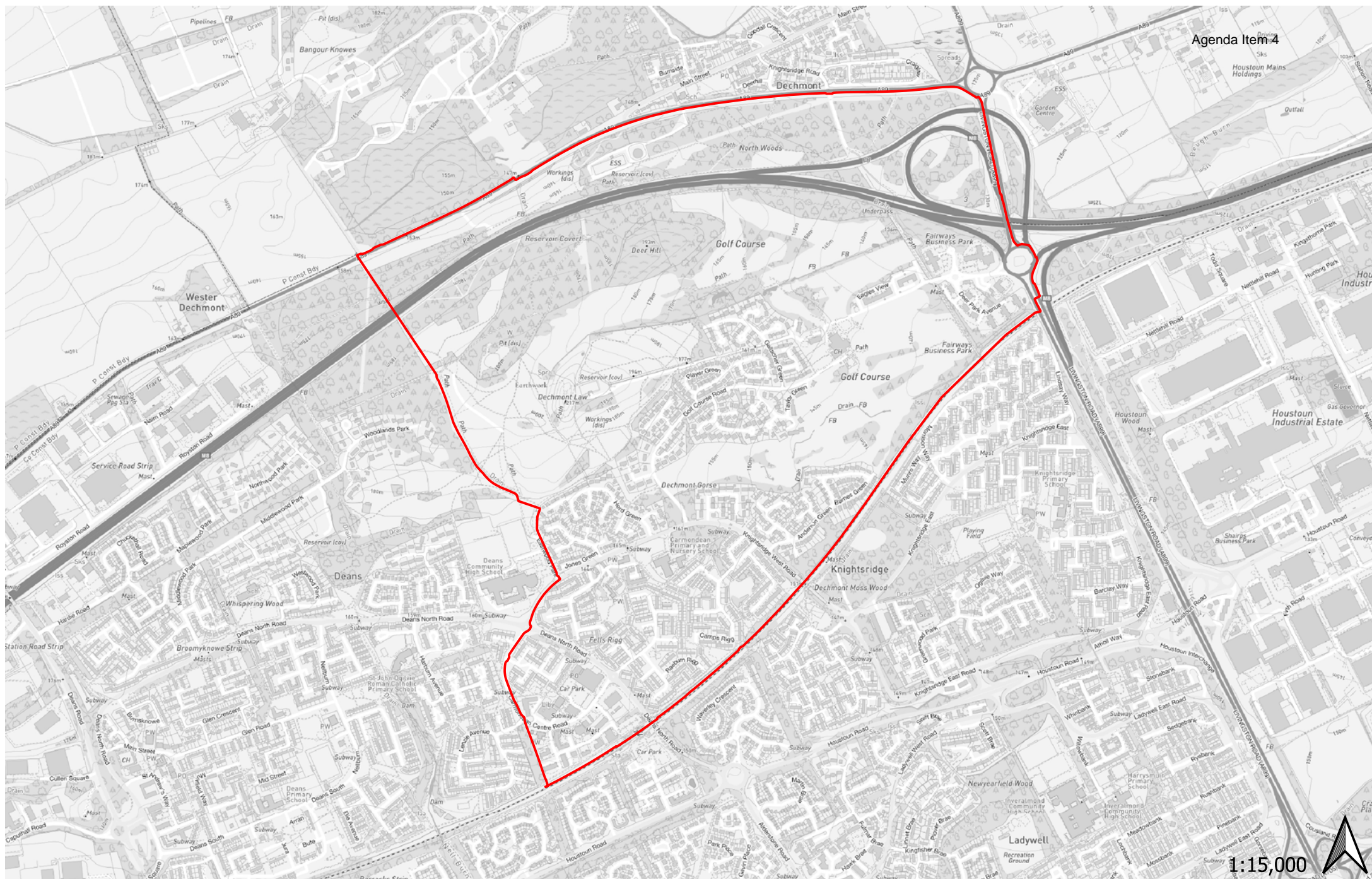

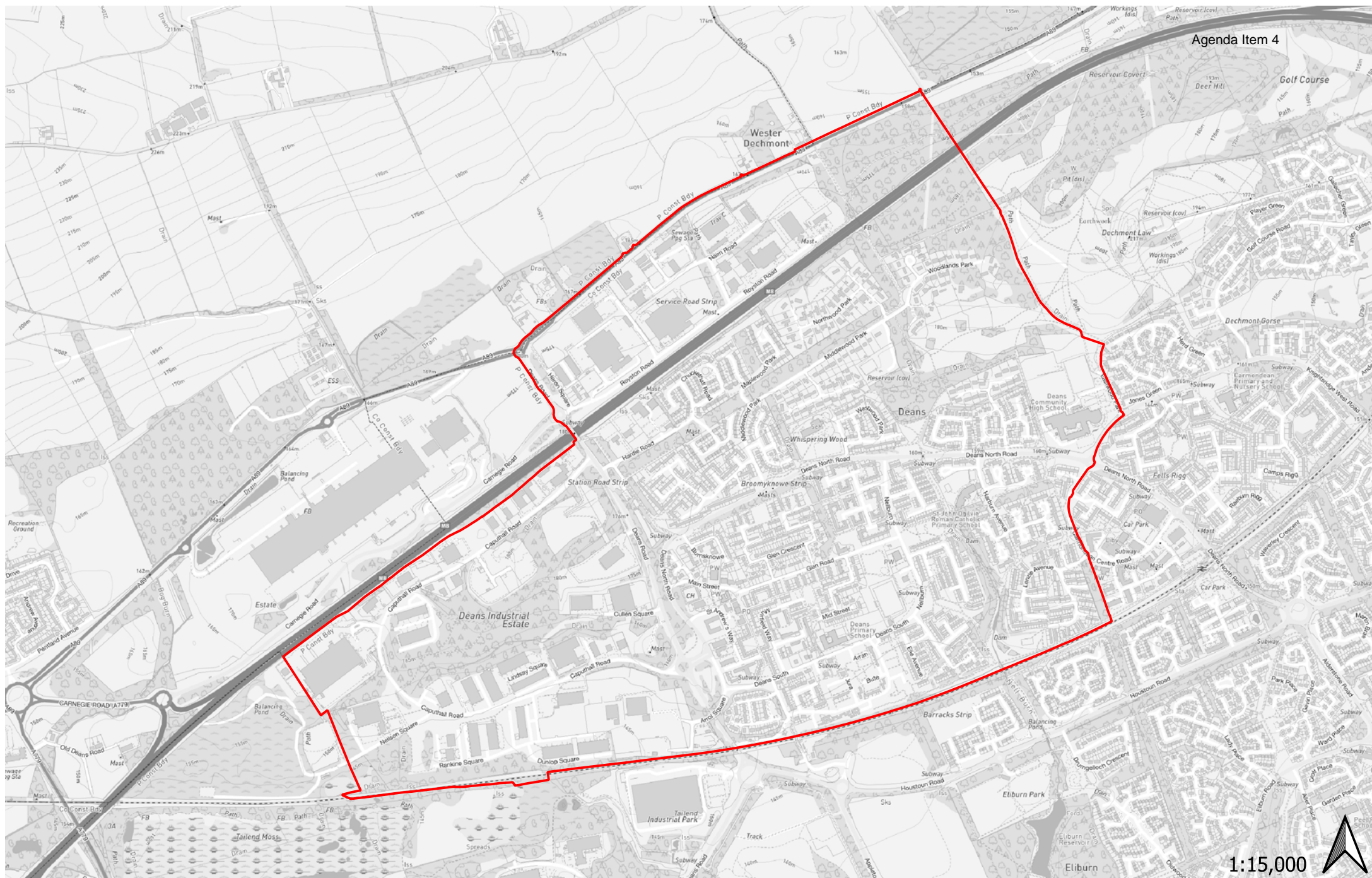

From</p> <ul style="list-style-type: none"> - parking at Arnold Clark showroom, to parking issues for local businesses. - ensuring that Livingston North retained a library service, - brought a successful, and much envied, art project to the area making 4 underpasses much more pleasant to travel through - added two new bus shelters to Carmondean Centre Road - placing art panels in 4 bus shelters - and finally raising funds to ensure lighting could be returned to these underpasses in time for the earlier dark nights. <p>This, along with many smaller issues, are quite an achievement considering half of the period of existence was covered by several lockdowns and reduction in council services.</p> <p>Community Council is an important link between a community and council officers. It is important that a good relationship develops between CC members and the officers as one of the main tasks of a community council is to liaise with officers.</p> <p>Many of the issues to be tackled in 2020/21 were top of the list to tackle in 2022. 		<p>REQUEST FOR AMENDMENT TO SCHEME FOR ESTABLISHMENT OF COMMUNITY COUNCILS IN WEST LOTHIAN REQUEST FOR THE FORMATION OF A SEPARATE CARMONDEAN COMMUNITY COUNCIL.</p> <p>I noted from the report that the council had “received a request from registered electors from the former Carmondean Community Council” to “re-establish a separate community council for Carmondean in its own right.” I also noted that this request was triggered by a ‘petition’.</p> <p>I read the terms of the report with great interest and to be honest, I was rather taken aback that the West Lothian Council would even accept such a request without bothering to establish if the purported reasons stated on the so-called ‘petition’ were with any substance.</p> <p>For example, one of the reasons cited by the ‘petitioners’ highlighted the fact that “the combined community council has led to Carmondean having no representation”. If anyone one had bothered to ask anyone from Carmondean & Deans Community Council if this were the case, then they might be surprised to hear quite a different story. From perusing through minutes of monthly meetings and talking to community councillors, I can provide you with a more accurate narrative.</p> <p>Following the dissolution of Carmondean Community Council on 13 October 2021 it was unanimously decided by the new Carmondean & Deans Community Council that the former [REDACTED] of Carmondean, [REDACTED] be elected as the new [REDACTED]. This took place at the inaugural meeting in November 2021. However, apparently after retaining the position of [REDACTED] certain behavioural issues arose including efforts to prevent the newly elected Carmondean & Deans Community Council from fulfilling its duty-bound obligations. This time, instead of using information from published minutes or snippets of information relayed in conversations with community councillors, I will just rely purely on common sense.</p> <p>The ‘petitioners’ claim that; “Carmondean has its own distinct heritage, community and needs, and that it should be represented by people from within its community”. As I have already pointed out there is an already established entity that represents the residents and interest of Carmondean, namely Carmondean & Deans Community Council. Furthermore, as I have also pointed out, it did and still does have people – representation currently provided by sitting councillors - from within the Carmondean community. The notion that it is not “represented by people from within its community” I utterly bogus. I suspect that one or more of the current ‘petitioners’ might be those who walked away from Carmondean & Deans Community Council!</p> <p>As for, “ heritage, community and needs”... might I suggest that this is a very thin argument indeed. Deans, formerly known as Livingston Station, has a heritage that goes back well over 150 years. Carmondean on the other hand is quite a new entity apart from the original farm that used to be there when it was just an area of farmland. On the surface its heritage is no more distinct from that of Knightsridge or Eliburn! Likewise, the community is comprised of the same social cohorts that can be found in Deans, sharing the same schools, shops, health centre, gala day, businesses, leisure facilities and entertainment venues and so on. Should Bathgate or Broxburn Community councils split because one area claims greater significance than the next in terms of “heritage, community and needs”? This idea that there is such a significant difference between Deans and Carmondean that it merits special treatment by boundary revision is quite simply nonsense.</p> <p>In summation, I trust that the council will see sense and throw this review out. Letter 1 to WLC from CDCC proposing a split – joint letter suggestion

Dear Lorrain (or whoever is appropriate)

December 2021

Proposed dissolution of Carmondean and Deans Community Council and re-instatement of individual councils for the Carmondean and Deans areas

We, as the two signatories below are writing you a joint email on behalf of the former Carmondean members and the new Deans members of the newly formed Carmondean and Deans Community Council. All members of CDCC have been contacted and asked for their opinions, and each has agreed with the decision to request the dissolution of CDCC and the re-instatement for CCC and DCC.

We would like, officially, to request splitting this joint CC into its former individual parts. We feel that the focus of the two areas is essentially different and we could make more progress if we act as separate units. We would like to stress that we have resolved previous difficulties, and intend to work in harmony with, but separately from, each other.

We recognise that this creates extra work for you, but are confident that this will be a catalyst for each council being more effective and co-operative.

Does the fact that the Model Constitution and Standing Orders have not been signed yet make this easier? Does it, for example, mean that the joint CDCC has not, in fact, been formally constituted, and that as a result dissolution could be speeded up, and the subsequent formation of individual CCs happen without undue delay? This would be the best result for us, and give us an energised start to 2022.

However, we appreciate that this might not be possible. If not, then we would continue in the interim as a joint council, but with the hope that you could action our request as soon as practically possible.

We believe that we have enough people to form two separate CCs. Initially, before the community council elections, CCC was concerned that we might not have enough people to keep going, while Deans members had been advised that setting up DCC would take an extended amount of time. These two factors lead to the creation of a joint CC that, in fact, neither group thought was ideal. Rather than continue with what was, for both groups, the fall-back option, we would be very grateful for any help you can give us to get back to our best option, being two councils.

Once we hear back from you, we will call an emergency meeting of CDCC to discuss how we are taking this forward together.

They advise, petition, influence and advocate numerous causes and cases of concern on behalf of local communities."</p> <p>In ■■■ short period of existence, ■■■ supported local business with car parking issues, assisted in ensuring that Livingston North retained a library service, brought a successful art project to the local community and recently saw the installation of lighting to the underpasses in the Carmondean Centre area.</p> <p>■■■ were able to do these because ■■■ listened to the views of the local Carmondean Community who brought issues to us.</p> <p>In 2020 ■■■ had hopes for many improvements in the area including at Livingston North Station and Carmondean Centre whilst continuing with smaller issues around Carmondean area, but the Covid Pandemic stopped all works. The upgrading of the Ability Centre to Livingston North Partnership Centre was delayed for months. Eventually works were completed and Carmondean Library was also then relocated to Livingston North Partnership Centre.</p> <p>It was a huge disappointment to have the Carmondean Connected Building (library) empty for almost 18 months but what a difference the new Prim8 martial arts gym has made to the building.</p> <p>Community Council is designed to be local. There are 39 local community council areas in West Lothian. Neither Carmondean nor Deans had had Community representation for many years. When asked to help create a new Carmondean Community Council in 2017 it was quite a daunting task, one which was accepted and taken on with great pride. By working together, a very small group of Carmondean residents successfully collected more that 20 signatures to ask WLC to officially form the council. We succeeded.</p> <p>While waiting for our inaugural meeting to take place we did our research on what we could and couldn't do, attended meetings of other community councils and began forming working relationships with council officers and councillors. That preparation made for a smoother launch.</p> <p>In 2020 WLC proposed merging areas that did not have a community council with neighbouring experienced ones. Deans had not had a community council in 20 years, so a Carmondean/Deans merger was suggested. Knowing there were many community concerns in Deans the proposal was agreed. The question of, "What</p>

The unanswered question was asked again as numbers would have allowed for Deans Community Council to be formed in its own right, but the decision was made to keep the combined one.</p> <p>It's now a year later and Deans have demonstrated that they have enough people to have a successful Community Council in their own Community. There is no need to have a conjoined Community Council.</p> <p>Carmondean and Deans are quite different communities and would be best served by separate Community Councils who could, when necessary, work together.</p> <p>Having Carmondean and Deans communities conjoined weakens the impact that two separate Community Councils can have. 

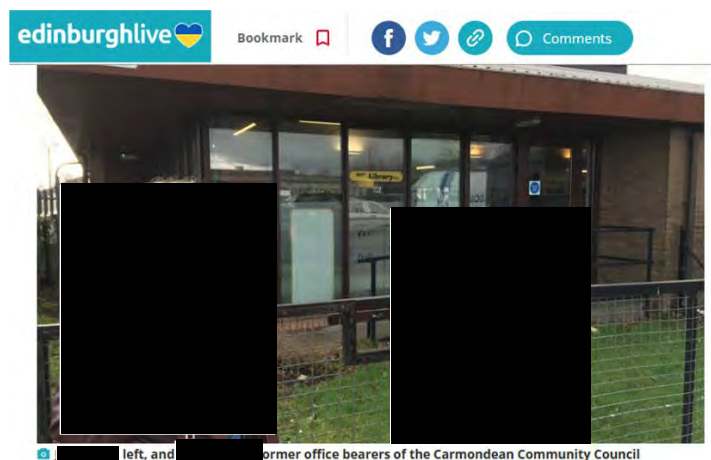

Jill Parton chair of the former Carmondean Community Council said: "It is felt that, as Carmondean has its own distinct heritage, community and needs that it should be represented by people from within its community.

It should be note that the headline reported on the above article is totally untrue. It was published the very first week of the consultation process. It presented a completely untrue narrative which I believe would fundamentally skew public opinion and perception over the coming weeks of the review process. I actually believe this may have been the intention in the first place. Therefore, let me be resoundingly clear, **Carmondean & Deans Community Council did not under any circumstances apply to split up**. Should we have been approached by the journalist or for that matter West Lothian Council, then an entirely different narrative may have come to light. However, what is clear from both cited articles is that the name of the former Carmondean Community Council [REDACTED] appears in both. It is also rather unfortunate that unlike the other local [REDACTED] [REDACTED] did not find the matter important enough to recuse [REDACTED] from the review proceedings in their entirety given [REDACTED] familiarity and relationship with [REDACTED]. That is a matter I may return to on a future occasion.

Let me now deal with the whole issue in greater detail.

Representation or Lack Thereof 1:

The 'petitioner's claim that **'the combined community council has led to Carmondean having no representation'** is completely without merit, and I would further suggest that the leading 'petitioner' knows full well that this apparent 'statement of fact' is blatantly and wilfully untrue. Carmondean & Deans Community Council has represented all residents equally throughout and will continue to do so despite the self-serving intentions of other parties. At this stage in my submission I would suggest that some attention needs to be paid to context and to the unfolding of events.

On 13 October 2021 Carmondean Community Council was dissolved. As a gesture of good will I suggested that the former [REDACTED] [REDACTED] should retain the same post in the newly established Carmondean & Deans Community Council. I was more than happy to offer my nomination, and [REDACTED] a self-proclaimed resident of Carmondean was duly appointed to the position of [REDACTED] in a unanimous vote at the inaugural meeting of the newly formed Carmondean & Deans Community Council in November 2021. However, and quite unexpectedly, no sooner had the new [REDACTED] assumed the role, she began to engage in behaviours that I and all the other community councillors found offensive and somewhat bullying in nature. I, along with several others, received questionable emails and a series of inappropriate dictates. Furthermore, the rapidly escalating problem of inappropriate behaviours increased to the point that they were seriously hindering the newly established Carmondean & Deans Community Council from functioning effectively, preventing it from carrying out its remit. Given the rapid escalation of behavioural issues [REDACTED] was removed from the position of chair on 10 January 2022. The [REDACTED] [REDACTED] [REDACTED] another resident from Carmondean and former Carmondean Community Councillor immediately assumed the [REDACTED] role by unanimous vote. [REDACTED] [REDACTED] remains the current [REDACTED] of Carmondean & Deans Community Council. It should be noted that on the same day [REDACTED] was appointed [REDACTED] [REDACTED] was appointed [REDACTED] [REDACTED]. The first two appointments by the newly appointed community councillors of Carmondean & Deans Community Council went to residents of Carmondean. This was a unanimous decision by all Deans residing councillors.

Following the former [REDACTED] removal from post, [REDACTED] remained a community councillor for Carmondean & Deans Community Council. However, from that point onward - 10 January 2022 - [REDACTED] did not attend any subsequent community council meetings. [REDACTED] effectively stopped representing the interests of those who live in Carmondean. Following failure to attend meetings on seven occasions and failure to represent, [REDACTED] was expelled from Carmondean & Deans Community Council on 15 August 2022. It should be noted that throughout this period, the [REDACTED] repeatedly offered the former [REDACTED] multiple opportunities to return and participate in the community council. [REDACTED] ignored all attempts to do so. Occasionally [REDACTED] would send an acidic email, mostly directed to the [REDACTED] [REDACTED]

Rather than work for the greater good of the residents whom we are all supposed to represent, the former [REDACTED] instead, continued in [REDACTED] efforts to break up Carmondean & Deans Community Council. I say continue because just three days after the 13 December 2021 monthly meeting [REDACTED] received an email. The email was dated 16 December 2021. [REDACTED] [REDACTED] was still the sitting [REDACTED] of Carmondean & Deans Community Council. The email contained a draft letter which carried [REDACTED] [REDACTED] at the bottom. It was drafted completely unbeknown to [REDACTED]. All statements of fact contained in the letter are untrue. The letter itself was dated December 2021. Everything outlined in the letter is wholly untrue. It should therefore come as no great surprise that [REDACTED] rejected this 'joint letter' outright.

The letter read as follows:

"Letter 1 to WLC from CDCC proposing a split – joint letter suggestion
Dear Lorrain (or whoever is appropriate) December 2021

Proposed dissolution of Carmondean and Deans Community Council and re-instatement of individual councils for the Carmondean and Deans areas

We, as the two signatories below are writing you a joint email on behalf of the former Carmondean members and the new Deans members of the newly formed Carmondean and Deans Community Council. All members of CDCC have been contacted and asked for their opinions, and each has agreed with the decision to request the dissolution of CDCC and the re-instatement for CCC and DCC.

We would like, officially, to request splitting this joint CC into its former individual parts. We feel that the focus of the two areas is essentially different and we could make more progress if we act as separate units. We would like to stress that we have resolved previous difficulties, and intend to work in harmony with, but separately from, each other.

We recognise that this creates extra work for you, but are confident that this will be a catalyst for each council being more effective and co-operative.

Does the fact that the Model Constitution and Standing Orders have not been signed yet make this easier? Does it, for example, mean that the joint CDCC has not, in fact, been formally constituted, and that as a result dissolution could be speeded up, and the subsequent formation of individual CCs happen without undue delay? This would be the best result for us, and give us an energised start to 2022.

However, we appreciate that this might not be possible. If not, then we would continue in the interim as a joint council, but with the hope that you could action our request as soon as practically possible.

We believe that we have enough people to form two separate CCs. Initially, before the community council elections, CCC was concerned that we might not have enough people to keep going, while Deans members had been advised that setting up DCC would take an extended amount of time. These two factors lead to the creation of a joint CC that, in fact, neither group thought was ideal. Rather than continue with what was, for both groups, the fall-back option, we would be very grateful for any help you can give us to get back to our best option, being two councils.

Once we hear back from you, we will call an emergency meeting of CDCC to discuss how we are taking this forward together.

Many thanks, and we look forward to hearing from you.

To reiterate so that there is no avoidance of doubt, I did not have any part in the drafting of this letter. I had no knowledge of its existence until it was sent to [REDACTED] via email. No one on the community council was ever contacted. No one agreed with any decisions. To be perfectly blunt, the whole letter was contrived by [REDACTED] the then sitting [REDACTED] in a self-serving attempt to try and turn the clock back so that [REDACTED] could once again hold power in [REDACTED] own little empire. Reading the letter, you will note that the main reason cited is the very same as those put forward by the current 'petitioner'; "two areas is essentially different." I will return to this point in due course.

This totally fabricated letter was contrived one year ago. It was just one of numerous subsequent occurrences that led to [REDACTED] being removed as [REDACTED]. As you should note from the dates, [REDACTED] actively sought the break-up of Carmondean & Deans Community Council while holding the [REDACTED] position. It should also be noted once again that after removal from office, and while remaining a community councillor with Carmondean & Deans Community Council [REDACTED] did not attend any meetings for a period of seven months. [REDACTED] utterly failed to represent those that the current 'petitioner' claims had no effective representation. Instead, whilst remaining a sitting community councillor, [REDACTED] continued to operate the old Carmondean Community Council Facebook page, albeit with an edited title. It should be further noted that [REDACTED] former [REDACTED] of Carmondean Community Council still operates this Facebook page as a de facto community council page. Additionally, [REDACTED] continues to use the following email: **CarmondeanCommunityCouncil@gmail.com**

Despite multiple complaints from Carmondean & Deans Community Council to West Lothian Council over the last twelve months to try and sort this nonsense out, it would appear from the lack of interest and any response that anyone can simply set up pseudo community council Facebook pages and pretend to be legitimately sanctioned community councils!

Representation or Lack Thereof 2:

The 'petitioner' also failed to state that when Carmondean & Deans Community was established four new community councillors were in fact residents of the Carmondean area: [REDACTED] the first [REDACTED] as mentioned above; [REDACTED] [REDACTED] the current [REDACTED] [REDACTED] and [REDACTED] [REDACTED] was the third appointment by Carmondean & Deans Community Council. [REDACTED] was appointed [REDACTED] but later resigned in the first quarter of 2022 citing personal reasons.

Another Carmondean based community councillor, the fourth, [REDACTED] [REDACTED] simply never attended any meetings, and [REDACTED] too was eventually removed although, at the time, a door remained open to [REDACTED] if [REDACTED] wished to return.

It should be clear that except for [REDACTED] [REDACTED] the current [REDACTED] the remaining three Carmondean community councillors effectively withdrew themselves from the community council process. It is wholly wrong to suggest that "the combined community council has led to Carmondean having no representation." It was the very representatives of Carmondean who, one way or another, withdrew their representation. A further manifestation of dysfunctionality that was observed by [REDACTED] [REDACTED] when he was part of Carmondean Community Council.

Currently we have three sitting community councillors that come from the Carmondean area, and we expect this to rise by another two early 2023. Despite others trying to hinder our progress, we have established a valuable network of contacts across or community council area and are very pleased to say that [REDACTED] [REDACTED] [REDACTED] [REDACTED] – a Carmondean resident – is now one of our newest community council members. I am also pleased to say that at the beginning of December, despite very short notice, we, along with our new Carmondean partners raised a substantial amount of money and goods for the West Lothian Council Festive Essentials Campaign. I would like to add that we are about to launch two more fundraising projects with our partners across Carmondean and Deans - residents and businesses alike. One to raise money for defibrillators and the other for funds for the local foodbanks operating withing the area.

With all due respect, I would suggest that West Lothian Council carry out a little due diligence to establish without question if the 'petitioner' or any of those mentioned on the

petition document have had any previous connection(s) to Carmondean & Deans Community Council. I would also ask West Lothian Council to consider the fact that Carmondean & Deans Community Council has never been contacted by either the 'petitioner', any signatories to the petition or concerned individuals. There has been absolutely no communication whatsoever, to bring any concerns that might be held to the attention of Carmondean & Deans Community Council. There has been absolutely no communication to enquire about establishing the true facts of the matter. There has been absolutely no communication to express any interest by any concerned individuals to join the community council to address concerns regarding perceived lack of representation. Might I suggest that all the above is quite intentional and that those who signed the 'petitioners' petition might have in fact been misled in order to fulfil the requirements of a deliberately misleading, clandestine and destructive agenda. **A simple self-serving agenda which does not put the needs of the residents first.**

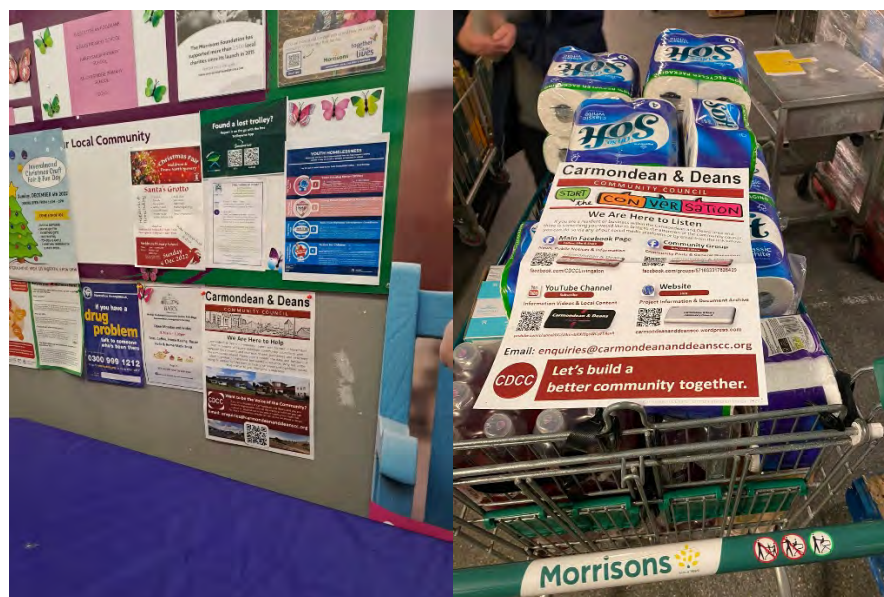

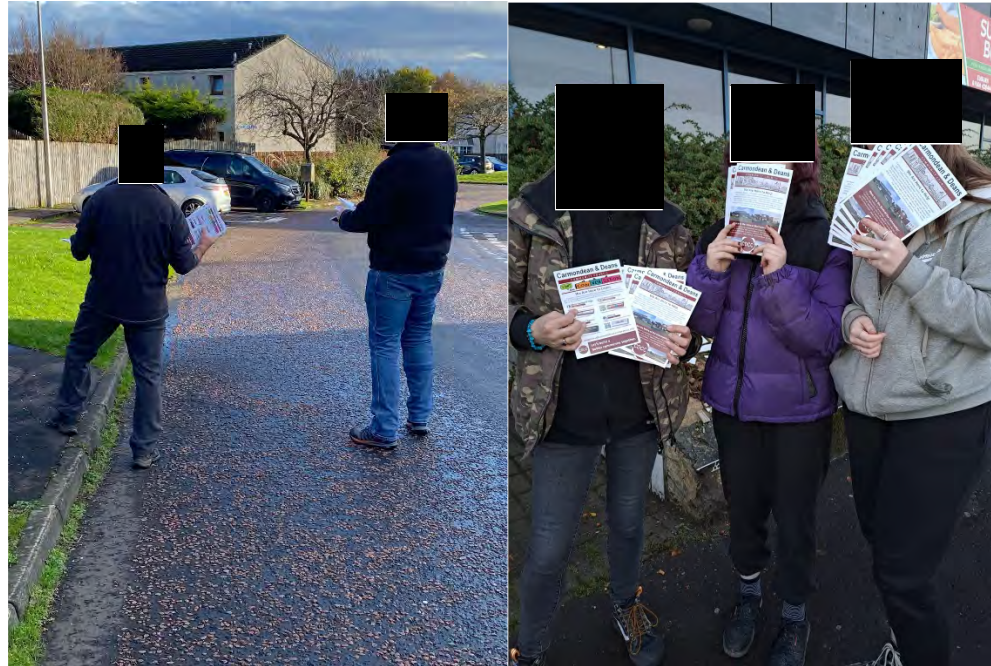
