1. <u>DECLARATIONS OF INTEREST</u>

There were no declarations of interest made.

2. <u>MINUTE</u>

The Board confirmed the draft Minute of its Meeting held on 12 February 2021 as a correct record. The Minute was thereafter signed by the Chair.

3. <u>ANNUAL FEES AND PREMISES LICENCE</u>

The Board considered a report by the Depute Clerk regarding a proposal from the Licensing Forum that the Board should consider refunding some premises part of their annual fees due to the impact of lockdown on operators. The background to the report was explained by the Depute Clerk and questions from Board members were answered by the Chief Solicitor and the Managing Solicitor of the Licensing Team.

Decision

To approve the report's recommendation that it would not be appropriate for the Board to determine that there should be a refund of any fees and to request that the Clerk inform the Licensing Forum of the Board's decision.

4. <u>RESPONSE TO GAMBLING CONSULTATION BY THE UK</u> <u>GOVERNMENT</u>

The Board considered a proposed response to the UK Government's consultation on the Gambling Act 2005. The proposed wording for the response had been prepared by the Depute Clerk and had been circulated to Board members by email prior to the meeting. The Depute

Clerk explained the issue raised in the proposed response and answered questions from Board members.

Decision

To approve the proposed response and authorise the Depute Clerk to submit the response to the Consultation.

5. <u>WEST LOTHIAN LICENSING BOARD GAMBLING POLICY</u> <u>CONSULTATION 2021</u>

The Depute Clerk highlighted that an email had been circulated to Board members prior to the meeting with a proposed consultation document and template letter for stakeholders in respect of a required Consultation to review the Board's gambling statement of principles. The Depute Clerk advised that as part of the review the Board would undertake a consultation process with a wide range of stakeholders and an online consultation through which anyone in West Lothian could submit a response to the consultation. The Depute Clerk advised that following the review a new gambling statement of principles required to be published by January 2022.

The Depute Clerk recommended that the Board note that a review of the Gambling Policy was underway with a view to the publication of a new statement of policy by January 2022 and approve the previously circulated consultation document and letter to stakeholders.

Decision

- (a) The Board noted that a review of their Gambling Policy was underway to include a public consultation with a view to the publication of a new statement of policy by January 2022;
- (b) To approve the proposed consultation document and letter to stakeholders circulated to Board Members by the Depute Clerk by email dated 26 February 2021 subject to adding premises licensed for on-sales of alcohol to the list of matters within the Board's remit for gambling (as stated on page 1 of the consultation document) and to delegate authority to the Clerk to make any final adjustments to the documents as required to correct any typographical errors or to deal with any other minor adjustments required.
