### 1. <u>APPOINTMENT OF CHAIR AND OPENING REMARKS</u>

In the absence of the Convener, nominations for Chair were invited from the members present in the absence of the Convener.

Councillor Doran-Timson, seconded by Councillor Dodds, nominated Councillor Heggie to chair the meeting. There were no other nominations and Councillor Heggie was unanimously appointed Chair of the meeting.

The Chair spoke of the recent passing of Councillor Dave King. He wished to pay respects to Councillor King who had been a very valued member of many council committees and the Board having served as a local councillor for almost three decades. The Chair extended his deepest condolences to the family of Councillor King and to his Labour Group colleagues. The Board then observed a minute's silence in memory of Councillor King.

3. <u>MINUTE</u>

## 4. <u>APPLICATION FOR VARIATION OF PREMISES LICENCE</u>
