1. DECLARATIONS OF INTEREST

No declarations of interest were made.

2. ORDER OF BUSINESS

The Chair advised members that the Panel Members from Services for the Community Policy Development and Scrutiny Panel had been invited to the meeting to participate in discussion on Agenda Item 5 (Housing Needs and Demand Assessment).

3. MINUTE

The panel approved the minute of its meeting held on 9 November 2021.

4. HOUSING NEEDS AND DEMANDS ASSESSMENT 3

The panel considered a joint report (copies of which had been circulated) by the Head of Housing, Customer and Building Services and the Head of Planning, Economic Development and Regeneration advising on the full report of the Housing Needs and Demand Assessment 3 (HNDA3) and to note the intention to submit a further report to Council Executive to seek approval to submit the HNDA3 report to the Scottish Government's centre for Housing Market Analysis (CHMA) for assessment with a view of achieving a "robust and credible" status.
